**Waiver**

Vendor agrees to indemnify Boss Hoss Promotions, Inc., Shriners Hospitals for Children, State of Tennessee, Boss Hoss Cycles, Inc. any and all sponsors of the 11<sup>th</sup> Annual Boss Hoss National Rally and their officers, directors, trustees, employees, agents, representatives, volunteers and servants, and anyone else connected with the management or presentation of the 11<sup>th</sup> Annual Boss Hoss National Rally and will forever hold and save each of them harmless from any and all actions, damages, and claims, to persons or property, penalties, obligations, liabilities or attorney's fees that may be asserted or claims by any person, firm, entity, corporation, political subdivision or other organization arising out of any negligent or intentional tortuous acts, errors or omissions of vendor, its agents, employees, sub-contractors, or invitees, provided for herein and arising out of the performance of this agreement. Vendor agrees to maintain booth space in a presentable manner. Vendor agrees to pay for removal of excessive trash and/or any clean-up charges necessitated by booth operation. Vendor agrees to pay a finance charge of 2% per month which is 24% per annum on past due accounts plus all costs of collection, including court costs and a reasonable attorney's fee in case suit or collection action is commenced to collect all or part of this account.

**Agreement**

In signing this contract, I agree to comply with the rules and regulations printed in this contract. I understand exhibit locations and space assignments are subject to approval by Boss Hoss Promotions, and that every attempt will be made to place vendors in the desired space. However, Event Management reserves the right to assign space on a first come basis. I agree not to relocate or sell any merchandise outside the assigned space or sub-let booth space. I understand acceptance of monies by Boss Hoss Promotions, Inc. under this contract is not binding if said money is returned by 9/16/10 and understand that no refunds will be given after event begins.
